Just sign into HomeTeller on your PC or laptop, or use our mobile app, then click the menu button and select "Remote Control Cards". Choose from your list of issued cards to select and change your card status to "active", "disabled", "lost" or "stolen". The change will be effective immediately. If you have temporarily misplaced your card, or are unsure of the validity of a transaction, you can disable your card until you resolve the issue. You can even keep your card in disabled status until you wish to use it, then disable it again once the transaction is complete. More control means more piece-of-mind.

Attention IRA Holders! 2017 IRA Deadline Reminder

All signs are pointing to springtime - the weather is warming up, the flowers are blooming, the birds are chirping, and the tax deadline is approaching!

As an existing or prospective IRA holder, below are a couple of important deadlines to note:

* The IRS allows you to contribute to the previous year (in this case, 2017) up until the federal tax deadline - April 17, 2018. If you opt to make your contribution after January 1st but before the April 17th deadline, you must designate the contribution year that you're targeting. This applies to most types of IRA accounts.

* The deadline for establishing a 2017 IRA is April 17, 2018. Per the federal government (and like taxes), a valid IRA application should be postmarked by midnight of the deadline for Traditional and Roth IRA accounts.
